

Application for Selection to Participate in the “Housing and Homelessness Professional Certificate Training” for Certified CRS/CHWs

Project Overview:

Corporation for Supportive Housing (CSH) through a grant from DMHA, has developed a Housing and Homelessness Certificate Training for individuals who are currently dually certified as CRS/CHWs in Indiana. With this additional training, dually certified CRS/CHWs will be equipped to help individuals experiencing homelessness and housing instability navigate and access housing resources, including supportive housing. Supportive housing is affordable housing linked to services like medical and behavioral health care that helps especially vulnerable individuals, many of whom experience co-occurring conditions, as well as homelessness, remain safely and stably housed.

This training is free to participants and the training curriculum will include 2 days of content, with additional supplemental self-paced learning modules. Training will be offered in both virtual and regional in person formats. Training dates will start in August 2022 and be scheduled through early 2023. If selected, you will be contacted regarding options for training dates.

Application Process:

1. Complete the attached application form and email it to Indiana.Institute@csh.org. We will be accepting applications through December 31, 2022; however the sooner you submit your application the sooner you will be offered a spot in one of the monthly trainings.

3. All applicants will be notified of their selection status starting on July 6th and as applications are submitted thereafter.
